WHAT ARE COOKIES

Cookies are small text strings that the applications visited by the User send to its terminal (to the browser), where they are stored before being re-transmitted to the same applications at the next visit by the same User.

Cookies are used to access online services more quickly and to improve User browsing through session monitoring, storing User information, faster content uploading, etc.

TYPES OF COOKIES

Cookies can be:

First-party cookies: they are the proprietary cookies used by the Site in order to allow the User to navigate more efficiently and / or to monitor the actions exercised by the same;

Third-party cookies: these are cookies set by a site other than the one you are currently visiting in order to allow the User to browse more efficiently and / or monitor the actions exercised by the same.

Furthermore, different types of cookies can be distinguished:

- **Technical and Analytical Cookies:** these are cookies related to activities that are strictly necessary for the functioning and delivery of the service (eg session cookies for login), cookies for saving preferences and optimization (eg, shopping cart cookies or of language / currency choices, etc.), analytical cookies to collect information in anonymous and aggregate form.

Technical cookies include:

- **Session or Navigation Cookies:** they are used to keep track of the User's activity on the network. They guarantee the normal navigation and use of the Site, allowing for example to navigate more quickly, to make a purchase or to authenticate to access restricted areas, and are in fact necessary for its correct functioning;
- **Functionality Cookies:** allow the User to browse according to a set of selected criteria (for example, the language, the products selected for purchase, etc.) in order to improve the service rendered to the same;
- **Analytical Cookies:** used to collect information on the use of the Site. The Owner uses this information for statistical analysis, to improve the Site and simplify its use, as well as to monitor its correct functioning. This type of cookie collects anonymous information on the Users' activity on the Site and on the way in which they arrived at the Site and the pages visited. Cookies in this category are sent from the Site itself or from third-party domains. Analytical cookies can be:
 - **First party Analytical Cookies:** similar to technical cookies when used directly by the Website Owner without profiling the User but only to collect information, in aggregate and anonymous form, on the number of Users and how they visit the Site for statistical purposes and to improve the performance of the Site;
 - **Third-party Analytical Cookies:** they are made available by third parties and are treated as technical cookies if the third parties do not profiling the User using appropriate tools to reduce the identifying power of cookies (for example, through the masking of significant portions of the IP

address) and without cross-referencing the information gathered with others they already have.

For technical cookie it is required only release of Cookie Policy without the need to obtain consent. Disabling or deleting them, accessing the functions of your browser, could compromise the optimal navigation on this Site.

- **Profiling Cookies:** they are used to monitor the User's web browsing and create a profile of his habits:
 - **First party profiling cookies:** installed by the Data Controller to create profiles relating to the User in order to send advertising messages in line with the preferences shown during web browsing. Given their particular invasiveness in the private sphere of users, the applicable legislation requires that the User, with adequate information on the use of the same, must express his consent;
 - **Third party profiling cookies:** used by third parties that access the information in clear, therefore not in anonymous and aggregate mode, and cross it with other data already in their possession. The Site does not have direct control of individual third-party cookies. The User is therefore invited to check the cookie policy on the website of the third party.

The use of these cookies requires the acquisition of the User's prior consent.

COOKIES INSTALLED

The cookies on this site are:

- **Technical and analytical cookies** (which are not stored permanently on the user's computer and disappear when the browser is closed) strictly limited to transmitting session identifiers necessary to allow a safe and efficient export of the site.
- **Third-party cookies**, which may carry out profiling and tracking activities of the User even without the knowledge of the Owner. For more information, we advise you to carefully consult the privacy policies of the individual services listed below.

Below is the list of cookies on this site:

CookieConsent: Stores the consent status of the user's cookies for the current domain. For more information, see the page: <https://www.cookiebot.com/privacy-policy/>

PHPSESSID Preserves the user's status on the various pages of the site. Required for site operation.

This site uses Google Analytics, a statistics and web analysis service, offered by Google Inc. It is aimed at identifying which pages are most viewed by site visitors, for how long they have remained within the same, the geographical area where they come from.

This information is processed by www.antislipgrating.com only for statistical purposes and in a strictly anonymous form. This site uses Google Analytics with anonymized IP addresses.

The information collected by Google Analytics, including the IP address of the visitor, is transmitted anonymously to the Google Inc. server. **These cookies cannot be used for profiling or identifying users**, but they are used exclusively for statistical purposes in aggregate form.

Google Analytics is a service provided by Google Inc. that uses cookies to measure visits to the Site and any purchases made for analysis purposes. Users IP address will be anonymized.

`collect of google-analytics.com` Used to send data to Google Analytics about the device and visitor behavior. It keeps track of the visitor on marketing devices and channels.

`test_cookie` Used to check if the user's browser supports cookies.

`IDE di doubleclick.net` Used by Google DoubleClick to record and produce reports on user actions on the site after viewing or clicking on one of the advertiser's advertisements in order to measure the effectiveness of an advertisement and present targeted advertising to the user.

■ Cookies of Youtube

Youtube is a platform owned by Google, for sharing videos, which uses cookies to collect information from users and navigation devices:

`@@History/@@scroll|#` Used by YouTube for access statistics, it expires when the session closes.

`GPS of youtube.com` Register a unique ID on mobile devices to allow tracking based on GPS location.

`NID` Register a unique ID that identifies the user device that returns to the site. The ID is used for targeted advertising.

`VISITOR_INFO1_LIVE of youtube.com` Try to estimate the speed of the user's connection on pages with integrated YouTube videos.

`PREF` Register a unique ID used by Google for statistics related to how the visitor uses YouTube videos on different websites.

`GPS` Register a unique ID on mobile devices to allow tracking based on GPS location.

`YSC of youtube.com` Register a unique ID for statistics related to which YouTube videos have been viewed by the user.

`yt-remote-connected-devices` Memorize the user's video player preferences using the built-in YouTube video

`yt-remote-device-id` Memorize the user's video player preferences using the built-in YouTube video

`yt-remote-cast-installed` Memorize the user's video player preferences using the built-in YouTube video

yt-remote-fast-check-period Memorize the user's video player preferences using the built-in YouTube video

yt-remote-session-app Memorize the user's video player preferences using the built-in YouTube video

yt-remote-session-name Memorize the user's video player preferences using the built-in YouTube video

DURATION OF COOKIES

Cookies have a duration dictated by the expiry date or by a specific action such as closing the browser set at the time of installation. Cookies can be:

temporary or session: they are used to store temporary information, allow to connect the actions performed during a specific session and are removed from the computer when the browser is closed;

persistent: they are used to store information, such as the name and password for access, so as to prevent the User from having to enter them again each time he visits a specific site. These remain stored in the computer even after closing the browser.

The User remains free to change the choices made at any time.

MANIFESTATION OF CONSENT

For cookies that require consent, at the first visit to the Site, the User automatically displays a banner, containing both the link to this complete information and the request for consent to the use of cookies.

You can change or withdraw your consent at any time.

You can freely accept or refuse to send all or some of our cookies from your terminal.

HOW TO DISABLE THE COOKIES

You can manage your cookie preferences directly within your browser and prevent third parties from installing cookies.

Through the browser preferences it is also possible to delete cookies installed in the past, including the cookie in which the consent to the installation of cookies by this Site has been saved. By disabling all cookies, the functioning of this Site may be compromised.

User Rights
