

PRIVACY POLICY OF COMPANY "LO SCALINO S.R.L. "
(EU Regulation 2016/679)

The purpose of this document is to inform Users about Personal Data collected by the company **LO SCALINO S.R.L.** through the website www.antislipgrating.com and the site management methods in relation to the processing of personal data of users who consult it.

THE HOLDER OF THE TREATMENT

Following consultation of this site, Personal Data relating to identified or identifiable persons may be processed. PLACE OF DATA PROCESSING

The processing of data relating to the site indicated above and at the Provider's office from which the website is hosted and are handled by the technical personnel appointed by the Owner and the Provider or by others in charge of occasional maintenance operations.

TYPES OF DATA - NAVIGATION DATA

Technical data: The computer systems and software procedures used to operate this website acquire, during their normal operation, some Personal Data whose transmission is implicit in the use of internet communication protocols, for example personal data, address of e-mail or postal mail and other contact details. This information is not collected to be associated with identified interested parties, but by their very nature could, through processing and association with data held by third parties, allow users to be identified. This category of data includes IP addresses or domain names of computers used by users who connect to the site, the time of the request. These data are used only to obtain anonymous statistical information on the use of the site and to check its correct functioning and are deleted immediately after processing. The data could be used to ascertain responsibility in case of hypothetical computer crimes against the site.

Usage data: Data relating to the use of the Application by the User may also be collected, such as, for example, the pages visited, the actions performed, the features and the services used.

DATA PROVIDED VOLUNTARILY BY THE USER

The Personal Data that may be sent spontaneously to LO SCALINO S.R.L., by sending electronic mail or by filling in appropriate forms, will be treated according to principles of correctness, lawfulness and transparency, for the protection of the privacy and rights of the

interested parties. Such data may be transferred to third parties only if necessary to provide the service requested by the user.

OPTIONAL PROVISION OF DATA

Except as specified for navigation data, the user is free to provide personal data to request the services offered by the company **LO SCALINO S.R.L.** or indicated in the "contacts" for any requests and / or communications. Failure to provide such data may make it impossible to obtain the requested service.

DATA PROCESSING METHODS

Personal data is processed using automated IT tools, with organizational methods and logic strictly related to the purposes indicated. Specific security measures are observed to prevent the loss of data, illicit or incorrect use and unauthorized access.

PERIOD OF DATA STORAGE

The Owner will process the Personal Data for the time necessary to fulfill the purposes connected with the execution of a contract between the Owner and the User and, in any case, no later than 10 years from the end of the relationship with the User.

When the processing of Personal Data is necessary for the pursuit of a legitimate interest of the Owner, the Personal Data will be kept until such interest is satisfied.

If the processing of Personal Data is based on the consent of the User, the Owner may keep the Personal Data until revocation.

Personal Data may be stored for a longer period if necessary to fulfill a legal obligation or by order of an authority.

All Personal Data will be deleted upon expiration of the retention period. Upon expiration of this term, the right of access, cancellation, rectification and the right to the portability of data may no longer be exercised.

User Rights

Users can exercise certain rights with reference to the Data processed by the Owner. In particular, the User has the right to:

- withdraw consent at any time;
- oppose the processing of their data;
- access your data;
- verify and ask for rectification;
- obtain the limitation of the treatment;
- obtain the cancellation or removal of your Personal Data;
- receive your data or have it transferred to another owner;
- lodge a complaint with the supervisory authority for the protection of personal data and / or act in court.
